

Ajit Doval Dares **Foreign Media** regarding **Operation** Sindoor **JAZZBAAT** NEWS DESK



Chennai: In a firm rebuttal to international media reports, National Security Adviser Ajit Doval publicly dared foreign press to "show me one photograph" that proves any damage was sustained in India during Operation Sindoor. The statement was delivered at the 62nd convocation of IIT Madras, where he also recapped the scope and precision of the military strike.

Doval reaffirmed that the operation, conducted at 1 a.m. on 7 May, targeted nine terrorist strongholds deep inside Pakistan and PoK, lasting a mere 23 minutes, with no collateral damage on Indian soil. "We missed none. We hit nowhere else except that," he asserted, underlining the mission's precision and restraint.

He criticised foreign media outlets, including the New York Times, for asserting that India came under retaliatory attacks. "Foreign press said that Pakistan did that and this, you tell me one photograph, one image, which shows any damage, even a glass pane having been broken," he demanded. These remarks contrast sharply with foreign reports asserting disruptions at 13 Pakistani air bases, such as Sargodha, Rahim Yar Khan, and Chaklala. Doval maintained that, unlike Pakistan, India emerged unscathed. •••• Contd. to P6

Centre Releases ₹1,066.80 Cr for Flood and Landslide Relief

New Delhi: The Union Government has approved the release of ₹1,066.80crore from the State Disaster Response Fund (SDRF) to help six states: Assam, Kerala, Uttarakhand, Manipur, Meghalaya, and Mizoram. These states are facing severe floods, landslides, and cloudbursts due to the ongoing monsoon. Union Home Minister Amit Shah announced this decision on Wednesday, emphasizing the Centre's commitment to support the states in all situations. He SDRF. More than ₹8,000

stated that the financial assistance would enable state governments to speed up relief, rescue, and rehabilitation efforts in the affected areas.

"The Modi government stands firmly beside the states in all situations. Today, the central government has approved ₹1,066.80 crore for flood- and landslide-affected states of Assam, Manipur, Meghalaya, Mizoram, Kerala, and Uttarakhand as part of the Central share under

media platform X. According to the allocation, Uttarakhand receives the highest share of ₹455.60 crore, followed by Assam with ₹375.60 crore. Kerala will get ₹153.20 crore, Manipur ₹29.20 crore, Meghalaya ₹30.40 crore, and Mizoram ₹22.80 crore. In addition to this latest

funding, the Centre has already released ₹6,166 crore from the SDRF to 14 states this year.

Another ₹1,988.91 crore has been distributed from the National Disaster Response Fund (NDRF) to 12 states.

Funds from the State Disaster Mitigation Fund (₹726.20 crore) and the National Disaster Mitigation Fund (₹17.55 crore) have also been approved for 2025. •••• Contd. to P2

NATIONAL **India Launches first Electric Truck Incentive Scheme under PM Modi's Green Mobility Vision**

New Delhi: In a major move to change India's freight transport system, the Government of India has introduced the country's first incentive program for electric trucks under the PM E-DRIVE initiative. Led by Prime Minister Narendra Modi and Union Minister for Heavy Industries and Steel H.D. Kumaraswamy, the scheme aims to encourage the use of electric trucks and cut emissions in the logistics sector.

Announced by the Ministry of Heavy Industries, the plan offers a maximum incentive of ₹9.6 lakh for each electric truck. This marks the first time the government is providing direct financial support for electric trucks, representing a key step in India's shift towards sustainable and low-emission freight transport.

At the launch, Union Minister H.D. Kumaraswamy stated, "Diesel trucks make up only 3% of the total vehicle population, yet they contribute to 42% of transport-related greenhouse gas emissions and greatly worsen air pollution. This innovative scheme, driven by the leadership of Prime Minister Shri Narendra Modi, is India's first dedicated support for electric trucks. It will lead our nation towards sustainable freight transport, a cleaner future, and the goal of Viksit Bharat by 2047, in line with our net-zero emissions target by 2070."

The scheme will apply to electric trucks in the N2 and N3 categories as defined by the Central

N2 vehicles include trucks with a gross vehicle weight (GVW) between 3.5 tonnes and 12 tonnes, while N3 vehicles cover those weighing more than 12 tonnes and up to 55 tonnes. For articulated trucks, the incentive will specifically apply to the puller tractor in

the N3 category. To guarantee reliability and performance, stringent warranty requirements are now compulsory. Batteries in the e-trucks must have a warranty for five years or 5 lakh kilometers, whichever comes first. The vehicle and motor must also be covered by a warranty of five years or 2.5 lakh kilometers. These stipulations aim to boost consumer confidence and promote the long-term use of electric trucks.

The financial incentive will directly reduce the purchase price and will later be reimbursed to Original Equipment Manufacturers (OEMs) through the PM E-DRIVE portal, which will follow a first-come, first-served approach. This initiative targets the deployment of about 5,600 e-trucks across India in its first phase. A specific allocation has also been set for Delhi, where around 1,100 e-trucks will be registered under the scheme. An estimated budget of ₹100 crore has been allocated for the capital to tackle its ongoing air quality crisis

Various sectors such as cement, steel, ports, and logistics

are likely to benefit from the scheme, especially since major OEMs like Volvo Eicher, Tata Motors, and Ashok Leyland have already started manufacturing electric trucks in India. This development also strongly supports India's Atmanirbhar Bharat mission, enhancing local capabilities in clean technology production. Public sector leader Steel Authority of India Limited (SAIL) has taken the initiative by committing to purchase 150 e-trucks over the next two years. These trucks will be deployed across SAIL units nationwide. To fur-

ther promote green operations, the company aims to ensure that at least 15 percent of all vehicles hired at its sites are electric. Importantly, to qualify for the

incentives, it will be necessary

but also maximize the environmental benefits by removing older, emissions-heavy vehicles from Indian roads.

The launch of this program is seen as a strategic move in India's larger electric mobility plan. By lowering the high upfront costs of electric trucks, the initiative aims to decrease operating costs for fleet operators and speed up the transition to clean energy in the heavy vehicle sector.

It also highlights the government's commitment to improving air quality in urban and industrial areas, steering the nation closer to its climate goals under the Paris Agreement.

With strong industry backing and a clear plan, the electric truck incentive scheme under PM E-DRIVE is poised to transform the future of freight transportation in India.

India's Space Pride on Hold: Shubhanshu Shukla's **Return from ISS Delayed**

New Delhi : Indian Group Captain Subhanshu Shukla, who went on a space mission to the International Space Station (ISS) as part of the Axiom-4 mission, had plans to return to Earth postponed for now. Although they were originally scheduled to return to Earth on July 10 in a SpaceX Dragon capsule, that schedule has been postponed due to weather and technical limitations, according to a joint statement from NASA and the European Space Agency (ESA). It is estimated that astronauts will not be able to leave the ISS before July 14th.

Subhanshu is joined by three other astronauts on this mission, all of whom have participated in space exploration through private initiatives. The Axiom-4 mission, a joint project of Axiom Space, SpaceX, and NASA, launched on June 25. After a 28-hour journey, they arrived at the International Space Station and began a series of important scientific studies. Their space-based mission is seen as part of preparations for long-term human habitation and research in space.

One of the major features of this mission was the germination test of Indian food grains, especially moong and fenugreek seeds, in the microgravity environment inside the ISS. In addition, they have participated in more than 60 scientific experiments related to biotechnology, materials science, artificial intelligence, and space medicine. Through this, not only India's research field but also international space research has been enriched.

Despite the success of the mission, there were some complications in returning it from the ISS to Earth. The Euro-

pean Space Agency said that a pressure loss problem was recently detected in the Russian Zvezda module of the ISS, which was later brought under control, but NASA is taking all precautions to ensure the safety of astronauts. Weather conditions are also an important consideration for the return, as the journey can be risky if sea conditions are not favorable during splashdown.

Just as the astronauts' families are concerned about this delay, ordinary people across the country are also waiting for their safe return. Shubhangshu's father, Shambhudayal Shukla, told the media, "We are proud of his space journey, but our hearts will not rest until we get news of his return." His mother, Asha Shukla, said, "We are keeping an eye on the news every day, hoping to know the date of his return."

Subhanshu Shukla is one of the rare group of people who have directly contributed to international space exploration on behalf of India. In 1984, Rakesh Sharma made history by traveling into space in a Soviet spacecraft. Now, Shubhangshu Shukla has repeated that history, albeit in a different context, through a private initiative. The Axiom-4 mission remains a saignificant chapter in the history of Indian spaceflight. The entire nation is now looking forward to that glorious moment-the day when Shubhangshu Shukla and his companions will successfully return to Earth. Their journey is not just a scientific mission, but also a source of inspiration for teaching the new generation to think about space.

Launches Whitepaper to



New Delhi: In a significant move to strengthen India's cybersecurity in the era of quantum technologies, the Ministry of Electronics and Information Technology (MeitY), along with the Indian Computer Emergency Response Team (CERT-In) and global cybersecurity firm SISA, launched a whitepaper titled "Transitioning to Quantum Cyber Readiness" in New Delhi on Friday. The whitepaper guides India's public and private sectors, including strategic industries, in preparing for a quantum-resilient digital future. It urges immediate action to secure vulnerable areas, especially in national security, sensitive public service data, and financial transactions. India, a global leader in digital payments and online services, faces challenges as encryption systems like RSA and ECC may soon become obsolete due to advancing quantum computing. This has prompted a government push for quantum-safe cybersecurity. 'Quantum readiness is a strategic necessity. As digital, AI, and quantum technologies evolve, we must upgrade ICT infrastructures quickly. This whitepaper offers the tools," said MeitY Secretary Shri S. Krishnan. The document outlines how quantum computing affects current cryptographic systems and provides guidance on adopting quantum-resistant algorithms and security protocols without disrupting ongoing operations.

CERT-In Director General Dr. Sanjay Bahl stressed early preparedness: "Quantum computing will redefine the threat landscape. We must evolve today to protect tomorrow's digital infrastructure. This partnership with SISA demonstrates the power of public-private collaboration." SISA CEO Dharshan Shanthamurthy added, "Quantum computing presents the biggest cybersecurity shift in over 30 years. It's a redefinition of computing limits. Systems we trust are vulnerable in a quantum context. For digital-first nations like India, our joint strategy with CERT-In offers real-world visibility and future-proof cryptographic defenses at the data layer." Tailored for regulated sectors like BFSI, healthcare, and government, the whitepaper includes technical recommendations and promotes a culture of cybersecurity and digital resilience. CERT-In, the national agency for cyber incident response under the IT Amendment Act, 2000, is responsible for threat analysis, alerts, and response coordination. SISA is a global cybersecurity leader in digital payments, certified by the PCI Security Standards Council, protecting over 1,000 organizations in more than 40 countries. As quantum computing reshapes digital security, the whitepaper marks a vital step in making India's digital infrastructure resilient and future-ready.

In the Northeast, Operation Jal Rahat-2, led by the Army, has rescued over 3,800 people in flood-affected areas. Relief teams have been sent to Upper Assam, where rivers like the Dhansiri in Golaghat have exceeded danger levels. Army units have also been dispatched to flood-hit areas in Dimapur, Nagaland, and in Imphal West and Bishnupur districts of Manipur, where rivers have overflowed.

The Centre's financial and logistical support comes amid significant damage to infrastructure, homes, and livelihoods across the affected states. This monsoon season has caused major disruptions, leading to a coordinated national response for both immediate relief and long-term recovery.

Indian Coast Guard Saves Two Americans around Andaman and Nicobar Islands **SULAGNA HALDER**

New Delhi: Indian Coast Guard (ICG) on 11 July 2025 confirmed that it had successfully saved two citizens of the US stranded on a yacht in the vicinity of the Andaman and Nicobar Islands as the US boat encountered a mechanical fault.

A statement released by the ICG said that the Sea Angel, an American-owned and flagged sail boat, had been sighted some 53 nautical miles south of Indira Point earlier on 10 July. The two on board, a US citizen and a Turkish national, had fancied a distress call through the US Consulate in Chennai in the face of rough sea conditions and the propulsion failure.

As a prompt reaction, ICG launched Ship Rajveer, which then sailed through dangerous waves to find the yacht. ICG said that the rescuers arrived at the boat when the sail was blown away and the propeller was caught in ropes. Both those in need of rescue were said to be in good health as the rescue took place.

The Sea Angel thereupon was taken under tow and in the morning of 11 July was safely landed in the harbour of Campbell Bay. A Defence Ministry communiqué added that this operation was well coordinated by the ICG with the help of the Maritime Rescue Coordination Centre (MRCC) Port Blair which also

alerted the merchant vessels nearby to join in case of need.

It comes barely a month after another international maritime rescue exercise by the ICG, under which three Sri Lankans stranded in a sandbar off the shores of Tamil Nadu were rescued and handed over to the local authorities. It is worth noting that the Indian Coast Guard organisation has even in a worst-case scenario, rescued the Sea Angel, and to think that it was a challenging environment in the Indian Ocean area underlines the increased efficiency and role of the Indian Coast Guard in emergency responses. Over the past few years, the ICG and Indian Navy have assumed a greater responsibility as first responders in the event of an incident of a foreign vessel.

These US nationals, whose identity and sailing route remained unknown, allegedly raised a distress call in the wee hours of 10 July, which is during the monsoon season. The mechanical problem on the yacht made it immobile, and this was a huge risk with deteriorating weather conditions.

After being towed to Campbell Bay, the persons were examined medically to see whether they were healthy. The yacht is locked in the dock awaiting technical examination and repair.



The ICG reiterated that it still upholds the so-called rescue coordination protocols and patrolling in the region to follow up with distressed vessels. One of the officials of the Ministry of Defence made the comment, saying that this shows that India extends its hand of security in the seas and is responsible for foreign vessels that might experience trouble in the waters of this region.

The rescue has earned rave reviews among maritime experts as a major demonstration that India can pull off timely and successful search and rescue operations in far-flung waters. It is also a lesson to all seafarers to be calm and highly prepared before untoward incidents happen at sea.



REGIONAL CHANDIGARH SATURDAY 12 JULY 2025 **Row Erupts as University Paper Labels Freedom Fighters 'Terrorists'**

Midnapore: A storm erupted at Vidvasagar University after a history exam paper wrongly described early 1930s freedom fighters from Midnapore as "terrorists", triggering outrage among students, academics, and political leaders. The university's Vice-Chancellor, Dipak Kumar Kar, has attributed the incident to a "printing mistake" and promised corrective action.

The contentious question, posed in Bengali, asked students to "name three district magistrates of Midnapore who were killed by terrorists," prompting immediate backlash once the paper was distributed on 10 July, the sixth semester exam day.

VC Kar addressed the issue in a statement issued on 11 July, saying, "A printing mistake occurred, it was unintentional and not detected during proofreading." He confirmed that two professors responsible for question setting and moderation had been relieved of their duties.

The History Department confirmed the English version had referred to "militant nationalists", but the Bengali translation omitted quotation marks, changing the context entirely. As Professor Nirmal Mahato, head of the department, explained: "The Bengali party "carries the legacy" of Congress-era

translation would have been correct had the term been placed within quotation marks." The mistake has sparked fierce criticism, with the BJP's West Bengal unit accusing the state administration of rewriting history to "poison young minds". Their social media post stated: "Freedom Fighters are now Terrorists in West Bengal!!!!"

The controversy has reignited longstanding debates. Observers note that during the colonial era, the British often labelled armed revolutionaries as terrorists, a contested interpretation today. Renowned historian Pabitra Sarkar has urged the state to revise history textbooks, warning: "It is very wrong to attribute negative things to these people.'

The university says it has initiated a review of the question-setting process to strengthen moderation and translation protocols. VC Kar remarked, "I am sincerely ashamed and extremely hurt. Those responsible for this typographical error and printing mistake were removed from their duties.³

Political reactions have been swift. BJP state chief Samik Bhattacharya blamed the ruling Trinamool Congress, stating the historical misinterpretations. In contrast, TMC spokesperson Kunal Ghosh argued that the error was confined to a few individuals: "Who made the question paper? It is entirely a matter related to a handful of individuals responsible for this."

Members of the Congress and CPM have condemned the gaffe as well, though they cautioned against politicising the issue. Adhir Ranjan Chowdhury of the Congress remarked on the need to stop "teaching incorrect history" and keep the debate centred on factual accuracy.

The incident comes mere months before West Bengal's assembly elections, injecting fresh tension into historical narratives and education policies. The VC assured that corrective measures will be taken before the next semester's exams: "We apologise for this inadvertent error, it is being investigated."

The university administration plans to publish revised question papers and offer re-examinations if needed. Academics urge that oversight mechanisms be tightened across the curriculum to prevent similar mistakes, stressing the need for vigilance when dealing with sensitive historical terminology.

Haryana School Principal Stabbed to Death by Students Over Haircut Order

Hisar: In a shocking incident where a school principal in the Hisar district of the state of Haryana was stabbed to death by two school students of Class 12 when he rebuked them on the refusal to take haircuts and follow the school discipline. This took place on 10 July on the school campus, which the police confirmed.

According to police reports, the principal, who was about 52, had confronted the students due to their untrimmed hair, which contravened the school dress code. Having requested them to be disciplined, he was later stabbed with a knife by the two boys, which caused his death on the spot.

A top police officer of Hisar said, the students were angered because they were advised to trim their hair and be disciplined according to school regulations. They picked a knife and stabbed him several times." The untimely demise of the principal has not only shocked the local community, but it has also cast great doubts concerning the safety of students in schools.

After the attack, the attackers escaped and have yet to be captured. A manhunt is currently on whereby teams of the Haryana Police, local administration, have been placed in road blocks and raising alerts district-wise to identify the suspects.

The incident has elicited a strict reaction from the education authorities and parents. One district education officer said the killing is something that is deeply offensive to them, and schools must be areas in which teachers and pupils are safe.

People who live around the school in the village have become shocked and alarmed. One of the parents, who talked anonymously, noted that we take our children to school in the hope of discipline and learning. We have never thought it could be so violent simply because of a haircut.

Answering back, the Minister of Education of the Haryana State ordered all the district schools to examine security measures. Among measures, one can distinguish the tightening of supervision on campus, the counselling of problem students, and the development of the concrete procedures of disciplinary action.

Child rights experts and activists have asked to strengthen counselling frameworks in schools. A local social worker, Anita Sharma, emphasised that students require having their directions and emotions supported. Discipline has to be taught in schools mixed with respect and empathy."

The Haryana government has said that it will assist the family of the deceased principal with ex gratia. In the meantime, the police have promised quick justice and requested that any person who may have information regarding the suspects present it to the authorities.

This case highlights a frightening trend in the degree to which there is student-on-teacher violence in India. It comes at a time when the issue of safety within educational institutions and psychological pressures exerted on adolescents are becoming major points of concern to the nation.

Going by the nature of the investigation, the police are likely to identify the possible suspects based on sections of the Indian Penal Code, such as section 302 against murder. The case has also come to light on the importance of schools to find a balance between discipline and emotional well-being.

After 27 Years on the Run

Key Accused in 1998

Coimbatore Blasts Arrested

COIMBATORE: One of the most wanted suspects in the 1998 Coimbatore serial bombings, A. Sadiq, also known as Tailor Raja, was apprehended in Vijayapura, Karnataka, on July 10, 2025, marking a significant breakthrough. Law enforcement agencies' nearly three-decade-long pursuit has come to an end. One of the most horrific terrorism cases in the nation is now nearing the end of the Supreme Court-monitored investigation.

The 1998 Coimbatore bombings, carried out on 14 February, saw 58 people killed and over 200 injured in a coordinated attack across 11 locations within a seven-kilometre radius, targeting a rally that senior BJP leader L. K. Advani was due to attend. Al-Umma, led by S. A. Basha, was identified as the mastermind organisation; Basha has since died in prison.

A special team comprising Coimbatore City Police and Tamil Nadu's Anti Terrorism Squad arrested Sadiq on intelligence suggesting he was living under the alias "Shahjahan Shaik" and working as a chilli commission agent. Officials say he had shifted between Hubballi, Solapur, Guntur, and finally Vijayapura, evading capture since 1996. Sadiq, now aged 50, is accused of orchestrating the bomb manufacturing at a rented house on Vallal Nagar in Ukkadam, from where he supplied explosives to other Al-Umma operatives in the days leading up to the blasts. He is also allegedly linked to a 1996 petrol bomb attack inside Coimbatore Central Prison that claimed the life of a jail warder and is further accused of murder during those years.

The investigation into the blasts has been a long-standing priority, with three special teams forming across Coimbatore, Madurai, and Trichy since 2022 to trace the remaining fugitives. A reward of ₹4 lakh was announced for information leading to the arrest of Sadiq and his associate, Mujibur Rahman, who also remains at large.

Tamil Nadu Director General of Police Shankar Jiwal confirmed the arrest, noting that two other wanted suspects had been apprehended recently in Andhra Pradesh. He emphasised that "Operation Aram" and "Operation Agali" are active intelligence-driven efforts to eliminate terrorism from the region.

The Tamil Nadu Chief Minister, M. K. Stalin, praised the collaborative efforts of the Karnataka and Andhra Pradesh police and lauded the Anti Terrorism Squad, established in 2023, for its role in securing Sadiq's arrest.

This arrest marks a critical milestone in the Coimbatore investigations. Despite the death of the alleged mastermind, Basha, in December 2024, and successful convictions including those against Basha and 12 other fugitives like Sadiq, had continued to elude justice.

Sadiq has been remanded in judicial custody until 24 July and will be lodged in Coimbatore Central Prison. Authorities intend to subject him to rigorous interrogation before seeking his transfer for trial under the Indian Penal Code and Terrorist and Disruptive Activities Prevention Act (TADA).

The search for the other suspects, such as Abubacker Siddiq, Ayub alias Ashraf Ali, and Mujibur Rahman, who are still thought to be hiding in four states, is still ongoing. For the victims of the 1998 attacks, their capture would be another step toward justice.

Bhagwat's Retirement Hint at 75 Sparks Buzz Over BJP's Future Leadership

New Delhi: In a political climate often filled with bold statements from BJP leaders about their longterm power, a single comment from Rashtriya Swayamsevak Sangh (RSS) Chief Mohan Bhagwat has triggered a flurry of speculation. Bhagwat, who shapes the ideology of the ruling party, suggested he might step aside after turning 75. This raises new questions about the future of the BJP.

While the BJP leadership confidently talks about its grip on power, Bhagwat's words have prompted many to wonder if a leadership change is in the works. Could the RSS be hinting at a new direction for the party it helped create?

Speaking at a book release event honoring late RSS ideologue Moropant Pingle in Nagpur on Wednesday evening, Bhagwat stated, "When you turn 75, it means you should stop now and make way for others." He recalled Pingle's message, saying, "Moropant Pingle once said that if you are honoured with a shawl after turning 75, it means that you should stop now, you are old, step aside and let others come in."

Notably, Bhagwat will turn 75 on September 11 this year, just six days before PM Modi, who has faced speculation from the Opposition about retiring at this age. The BJP has previously stated that



there are no retirement plans for the Prime Minister, and he will continue to lead. "Modi ji will continue to lead till 2029. There's no truth in retirement rumours," Union Home Minister Amit Shah affirmed back in May 2023.

What's even more interesting is

that on the same day Bhagwat made his comments, Amit Shah discussed his own post-retirement plans at a separate event. "I would like to dedicate my time to the Vedas, Upanishads, and organic farming," Shah said. He turned 60 in April this year.

THE BATTLE FOR BIHAR Democracy at the Crossroads

The Bihar Assembly election set for later this year is shaping up to be more than just a political contest. It is becoming a critical test for India's democratic processes. The pre-election narrative, led by the Election Commission's controversial Special Intensive Revision of electoral rolls, has sparked a heated debate about voter rights and disenfranchisement. With 8 crore registered voters in the state under scrutiny, the stakes could not be higher. The Election Commission says the revision aims to clean up the rolls by removing duplicates and outdated entries. However, opposition parties argue that the effort mainly targets voters from marginalized and backward communities. Concerns grew when the Commission reportedly refused to accept Aadhaar cards, voter IDs, or ration cards as valid proof, bringing the issue to the Supreme Court. In a key hearing on July 10, the Court directed the Commission to accept these documents and to avoid arbitrary deletions. Congress leader Jairam Ramesh criticized the Election Commission's stance, calling it a "spin" and warning that the credibility of the electoral process was at risk. Editorials in major newspapers have echoed similar worries, urging the Commission to prioritize transparency and inclusion. As The Economic Times pointed out, the poll body must "update the rolls, not erase citizens."

As this situation develops, Bihar's political landscape is changing quickly.

The ruling NDA, led by the Bharatiya Janata Party and Janata Dal (United), is actively courting Bihar's three crore migrant voters. Many of these voters live and work in other states but still retain voting rights in Bihar. The BJP has launched a large outreach effort, sending teams to over 150 districts nationwide to encourage migrants to return for polling day.

Within the NDA, a new voice is stepping forward. Chirag Paswan, president of the Lok Janshakti Party (Ram Vilas), is back as a strong contender. Running under the slogan "Bihar First, Bihari First," Chirag is presenting himself as a youthful alternative to both Tejashwi Yadav and Nitish Kumar. His party has been especially active in Dalit-majority constituencies and urban areas, where development promises resonate with voters aiming for progress. Chirag's challenge is to balance legacy politics with a fresh image. As the son of the late Ram Vilas Paswan, a significant Dalit leader, he has strong emotional support from Paswan voters. Yet, he is also promoting a governance-focused message, criticizing both the RJD and JD(U) for years of neglect and tokenism. Meanwhile, the Mahagathbandhan is showing a united front. RJD's Tejashwi Yadav has been officially named as the chief ministerial candidate by all alliance partners, including the Congress and the Left. Kanhaiya Kumar, a key Congress figure in Bihar, recently stated that there is "no confusion or dispute" over Tejashwi's leadership. The alliance is finalizing seat-sharing deals, with the Congress expected to contest around 40 to 45 seats, while VIP leader Mukesh Sahani is seeking more than 10. Tejashwi's campaign emphasizes job creation, education, and social justice. He is also trying to regain the Extremely Backward Class vote, which was once a stronghold for Nitish Kumar, by invoking his father Lalu Prasad Yadav's legacy of Mandal politics. Further adding to the contest is the rise of a new generation of political leaders. Tejashwi Yadav, Chirag Paswan, Samrat Choudhary of the BJP, and political strategist-turned-politician Prashant Kishor are working to reshape Bihar's politics from caste dynamics to development-focused narratives. While caste still plays a big role, young leaders are offering a more varied vision. Ultimately, this election is a test for Bihar's institutions and its voters. Will the Election Commission fulfill its constitutional duty to protect voter rights? Can Bihar rise above political gimmicks and polarization to select leadership based on vision, performance, and inclusiveness? As Bihar approaches polling day, the emphasis must stay on fair processes, real representation, and meaningful public discussion. The 2025 election is not just about who wins. It is about whether democracy wins.

THE MAN WHO SAVES 95% OF HIS INCOME A Financial Advisor's Radical Approach to Wealth Building

A tweet by Akshat Shrivastava about saving 95 percent of his annual income has become a controversial subject, with hundreds of thousands of views and arguments about financial discipline and quality of life. The story of Shrivastava starts at a modest point. After leaving college, he got a salary of only 10000 rupees per month and lived with his parents. Owning a second-hand phone and living on home-cooked food, he could still save about 1000-2000

a month. According to him, he was in no debt, did not have a fancy lifestyle, and had simple habits.

The main challenge was when his revenue went up to 50 lakh per year. However, majority would improve their lifestyle in the same ratio, Shrivastava kept his habits of frugality. He has continued to live debt-free and saves 20 lakh per annum investing much in high-growth investments.

Shrivastava says today, being a married man with kids and staying in one of the costliest metropolitan cities that he still ably manages to save 95% of his income as he travels both

Elon Musk Steps into Politics: Could He Run for U.S. President?

California: Elon Musk, the CEO of Tesla and SpaceX and the world's richest person, played a major role in Donald Trump's second term in office in 2024. But now he has entered American politics himself. Last Saturday, he announced a new political party called the "America Party." Musk claims that this party will become the voice of the 80 percent of middle-class voters in America who are neither Republicans nor Democrats.

According to those close to Elon Musk, his announcement was very natural, because Donald Trump recently passed the "Big Beautiful" law in the US Congress. Musk was against the bill. While Trump was supporting the bill and presenting its merits to opponents, Musk said that if the bill passed, he would announce a new party for the American people. Musk also said that this bill would be disastrous for the American people. According to Musk, this bill would only benefit the rich, not the poor and middle class.

Meanwhile, the most important question that has been raised since the announcement of Elon Musk's party is whether Elon Musk himself will be able to run for president this time. In this context, it is not easy for anyone to run for president in America. According to Article II, Section 1 of the US Constitution, a person can only become President of the US if they meet

three specific conditions. The first condition is that he must be a natural-born American citizen. The second condition is that he must be at least 35 years old and have lived in America for at least 14 years.

One of these important conditions is not met in the case of Elon Musk. In fact, Musk is not an American citizen by birth. Musk was born on June 28, 1971 in Pretoria, South Africa. He later became a US citizen. But because he is not a "natural born U.S. citizen," the Constitution does not allow him to run for president.

Despite his vast wealth and control over technology and business, that provision of the US Constitution has blocked his path to becoming President of the United States. In this situation, Elon Musk will never be able to become the US President unless the Constitution is amended. Meanwhile, such an amendment is extremely difficult. Because it requires a two-thirds majority in both houses and then the approval of 38 out of 50 states. According to political analysts, Elon

Musk is now moving from "kingmaker" to "powerbroker." He may nominate his candidate in the 2026 midterm elections. He may also nominate an American-born leader for the 2028 presidential election. In addition, he himself may be the head, policy director, or source of funding for that party.

Canada Braces as US President Trump Imposes 35 % Tariffs, What's Next?

Ottawa: Canada is preparing to retaliate diplomatically and economically after US President Donald Trump announced on 10 July a steep 35 percent tariff on a wide range of Canadian imports, due to take effect on 1 August. The announcement, sent in an open letter via Trump's Truth Social account to Prime Minister Mark Carney, cited Canada's alleged failure to curb fentanyl trafficking and border enforcement as the primary justification.

Mr Carney responded swiftly. He pledged to "defend Canadian workers and businesses" and signalled willingness to negotiate a new trade deal before the deadline, aiming to avert what he called "unjustified" measures. He also pointed to progress in Canada's efforts to counter fentanyl flows, dismissing the US claims as "not supported by evidence". The 35 percent levy exceeds prior tariffs, which stood at 25 percent for non-USMCA goods. The latest proposal could override existing exemptions under the North American Trade Agreement. Canada's dollar fell initially, although markets later regained some composure as investors speculated on the outcome of negotiations.

In response, Ottawa is evaluating countermeasures. Government officials confirmed that Canada has already imposed equal retaliatory tariffs on US steel, aluminium, and various other goods, with the option to extend such measures. Another possible tool is non-tariff actions affecting energy, critical minerals or procurement policies.

Analysts caution that the move could reverberate through both economies, disrupting everything from automotive supply chains

to agricultural exports. Canadian premiers are urging the defence of domestic industries, with some provinces hinting at boycotts of American goods. During earlier rounds of tariff escalation, nearly 90 percent of Canadians reportedly favoured reducing reliance on the US.

Mr Trump's letter offered a sliver of flexibility: he indicated the tariffs may be revised, "upward or downward" depending on Canadian cooperation. He further suggested a broad expansion of general tariffs (15-20 percent) on other trading partners. Observers noted that this message followed similar tariff threats to 23 other nations, including Brazil and Mexico.

Markets reflected the uncertainty. The Canadian dollar dipped against the US currency after the announcement, and stock futures showed signs of volatility, even as the S&P 500 and Nasdaq held record highs.

Canada remains open to diplomacy. Mr Carney has set 21 July as a revised deadline to conclude new trade terms, signalling his government's intent to restore stability.

Experts believe the US may soften its approach if Canada demonstrates a willingness to resolve contentious issues, particularly on trade barriers and drug control.

However, analysts warn that the broader climate of "tariff whiplash" marks a departure from post-war free-trade norms, reviving fears of escalating protectionism. As negotiations proceed, both governments face mounting pressure: Canada to defend its industries and sovereignty, and the US to balance domestic political demands with the risks of alienating its top trading partner.



US Warns Citizens Against Iran Travel Amid Rising Detention, Terror Risk

WASHINGTON: The US State Department on 11 July issued its strongest warning yet for American citizens, advising them not to travel to Iran for any reason. The updated Level-4 advisory, the government's highest travel alert, cites escalating threats, including wrongful detention of US nationals, heightened terrorism risk, and misleading surrogacy practices.

In a statement, spokesperson Tammy Bruce emphasised the severe danger faced particularly by dual US-Iranian nationals, warning that the Iranian authorities "do not recognise dual nationality" and may treat such individuals solely as Iranian citizens. She noted that "US citizens in Iran face serious dangers. They have been kidnapped and wrongfully arrested. Some have been held for years on false charges, subjected to psychological torture, and even sentenced to death." The State Department also

US State warned of threats from Iranian-affiliated extremist organisations, including an intensified risk of bombings and violent reason. crimes perpetrated by ISIS and dvisory, similar groups. In parallel, the Federal Aviation Administration threats, (FAA) has barred US airlines and aircraft from flying to, from, or through Iran due to heightened risks in Iranian airspace.

A notable addition to the advisory is a caution over Iran's unregulated surrogacy industry. US officials warned that some surrogacy providers in Iran have misrepresented US citizenship rules. "If a child born overseas to a surrogate is not genetically or gestationally related to a US citizen parent, the child will not automatically acquire US citizenship at birth and will not be able to obtain a US passport to leave Iran," the advisory stated. To help travellers plan ahead, the State Department launched a new website offering detailed

curity updates for Americans considering travel to Iran. It also continues to recommend that US citizens contact the Smart Traveler Enrollment Program (STEP) to receive alerts from US embassies and consulates.

The warning comes against a backdrop of sharply deteriorating Iran-US relations following a series of Israeli strikes on Iranian nuclear facilities in June, supported by US military assets. The strikes prompted a broader 'Worldwide Caution' alert for potential retaliatory violence and cyber attacks against American citizens and interests abroad.

Recent State Department cables revealed that hundreds of US citizens have left Iran recently via land routes following airspace closures. These evacuations were marked by delays, reports of harassment, and at least two detentions.

The warning underlines the absence of diplomatic channels,



leaving the Swiss Embassy in Tehran as the US's "protecting power," although access to detained Americans, particularly dual nationals, has often been delayed or denied.

US officials emphasised that the advisory is not merely cautionary but reflects grave risks. They urged any American still in Iran to plan immediate departure via land to neighbouring nations such as Azerbaijan, Ar-

n menia, or Turkey.

Countries under Level 4 "Do Not Travel" include Iran, Israel, Iraq, Syria, Yemen, and Lebanon, with threats spanning terrorism, kidnapping, civil unrest, and arbitrary detention.

This advisory is a stark reminder of the tenuous safety for US citizens in Iran. It leaves little room for exceptions, especially as geopolitical tensions in the region continue to escalate.

India's retaliation with Operation Sindoor followed the 22 April terror attack in Pahalgam, where 26 civilians, including Indians and Nepalese, were killed. Doval emphasised that the military response was "calibrated, measured and non-escalatory", aimed solely at terrorist infrastructure.

In coordination with global partners, Doval detailed that he had briefed security counterparts in the US, UK, Japan, Russia, China, and Gulf nations on India's non-escalatory strategy. "India had no intent to escalate but was prepared to retaliate resolutely if Pakistan decided to escalate," he said.

y At the same gathering, Doval pressed for consistency in global counter-terror messaging, denouncing "double standards" and urging collective action against groups like LeT, JeM, Al-Qaida, and ISIS.

He reminded the audience that India maintains an unwavering commitment to sovereignty and strategic deterrence. Reports of damage within Indian territory, he stressed, were misleading and lacked substantiation. "I'm only telling you what the foreign media put out on the basis of im-

ages," he added. Operation Sindoor ended on 10 May when India and Pakistan agreed to resume a ceasefire, marking a tenuous return to relative calm. However, Doval warned that India remains "closely monitoring" the situation and will "retaliate resolutely" if cross-border terrorism persists.

Superman review: James Gunn and David Corenswet bring hope back to the Man of Steel

Kapil Sharma's Canada **Cafe Targeted by Khalistani Terrorists Over TV Show**

New Delhi: It happens to us all. It is yet another Superman film, another vow that this time they will get it right. However, here is the thing: James Gunn comes through. His Superman not only crashes into theatres with a splash, but flies with the kind of joyous exuberance that we forgot was possible in superhero films.

In a landscape littered with grim-faced heroes wrestling with their demons, Gunn's film feels almost rebellious in its optimism. This isn't your typical Hollywood reboot designed by committee; it's a love letter to everything that makes the Man of Steel endure, wrapped in the kind of genuine heart that makes you remember why you fell in love with superheroes in the first place.

David Corenswet gives an impressively confident and confidently fitting jump in the legendary cape and gets a Superman who is both classical and invigoratingly new. In contrast to other versions that could not find a balance between the two versions of Clark Kent, Corenswet has a unified character: earnest, vulnerable, and hopeful indeed. His Superman doesn't brood about the burden of his powers; instead, he wrestles with finding his place in a world that desperately needs heroes but isn't sure it wants them.

The film wisely skips the tired origin story, dropping us into Superman's third year of heroism. When an international intervention goes sideways, our hero faces his first real crisis of confidence. It's a smart narrative choice that allows Gunn to explore what makes Superman compelling: not his invulnerability, but his humanity.

Rachel Brosnahan's Lois Lane is a revelation, sharp, fearless, and every bit Superman's equal. The chemistry between Corenswet and Brosnahan crackles with the wit and warmth that made the Christopher Reeve films so beloved. Their banter feels natural, their ro-

mance genuine, and their partnership essential to the story's emotional core.

Nicholas Hoult brings a calculating menace to Lex Luthor, crafting a villain who's both intellectually formidable and disturbingly petty. His Luthor doesn't just want to destroy Superman; he wants to prove that hope itself is a lie.

Gunn's signature style, vibrant colours, quirky humour, and genuine heart transform Superman into a living comic book. The film embraces its source material's inherent absurdity while never mocking it. From Krypto the Superdog's scene-stealing antics to the Justice Gang's eccentric heroics, every element feels purposeful rather than gratuitous.

The action sequences are spectacular, particularly a breathtaking single-take fight scene that showcases Superman's powers with genuine awe. John Murphy's soaring score pays homage to John Williams while establishing its own identity.

Superman occasionally stumbles under the weight of its ambitions. The film juggles numerous subplots and supporting characters, sometimes at the expense of deeper character development. Gunn's penchant for humour, while mostly successful, occasionally undercuts moments that could use more emotional weight.

What Superman accomplishes is remarkable: it makes the Man of Steel relevant again. In an era of cynicism, Gunn presents a hero who chooses hope not because it's easy, but because it's necessary. The film's optimism feels radical, its earnestness punk rock.

This isn't just a successful Superman film; it's a blueprint for how superhero movies can evolve beyond darkness into something more inspiring. With stellar performances, spectacular action, and a heart bigger than Metropolis, Superman proves that sometimes the world needs saving, and sometimes the movies do too.



Mumbai: Mumbai Police visit comedian's residence as cafe vows to continue operations despite attack. Comedian Kapil Sharma's newly opened restaurant in Canada became the target of an attack by Khalistani terrorists, who claimed responsibility for firing multiple shots at the establishment in Surrey, British Columbia, on Wednesday night. The attack on Kap's Cafe, which opened just a week ago on July 4, was orchestrated by Harjit Singh Laddi, a member of the proscribed terror outfit Babbar Khalsa International (BKI). Laddi, who appears on India's NIA most-wanted list, claimed the assault was in response to Sharma's comedy show allegedly mocking Nihang Sikhs. According to Laddi, a participant had made "humorous remarks" about Nihang Sikh dress and conduct, offending reli-

gious sentiments. He alleged that no public apology was issued despite repeated calls to Sharma's team. "No religion or spiritual identity can be mocked under the guise of comedy," he said, naming himself and associate Toofan Singh as the shooters. Surrey Police responded around 1:50 AM local time, confirming shots were fired while staff were present. No injuries were reported, but the property was damaged. Mumbai Police visited Sharma's Oshiwara residence on Friday to confirm his address. Officials said no statement was recorded, and security was not increased. The cafe released a statement expressing shock but determination to continue: "We opened Kap's Cafe with hopes of bringing warmth, community, and joy... To have violence intersect with that dream is heartbreaking.

We are not giving up. The cafe reaffirmed its stance against violence, promising to remain a space for community. This incident highlights growing concerns over extremist actions in Canada and groups like BKI, considered terrorist organisations by the Canadian government. It raises safety concerns for Indian diaspora businesses amid rising radicalism.

The terrorists claimed to protect Nihang Sikhs, a traditional Sikh martial order known for blue robes and adherence to classical Sikh values. The community is historically associated with defending Sikh religious and cultural traditions. As investigations continue, the incident stands as a stark reminder of how extremist groups exploit cultural sensitivities to justify violence against civilians and businesses
